

# Data protection declaration for newsletter

This information is to inform you of the content of our newsletter and your rights in regard to it. By subscribing to our newsletter, you agree to its receipt and the following terms.

- a) **Responsible party and data protection officer:** The responsible body pursuant to data protection law, in particular the EU General Data Protection Regulation (GDPR), is Rothenberger AG, Spessartstraße 2–4, 65779 Kelkheim, Germany. - b) **Content and purpose of processing:** We process the personal data that you provide when registering for the newsletter, in order to send the newsletter.

When the newsletter is retrieved, the following technical information is collected:

- Address of the requesting device
- Date and time of access
- Name and URL of the requested file
- Amount of data transmitted
- Access status (file transferred, file not found, etc.)
- Detection data for the browser and operating system used
- Name of user's Internet access provider
- Information on the website from which access is made

This information is used for technical improvement of services.

It is also automatically detected whether the newsletter is opened, when it is opened, and which links are clicked. For technical reasons, this information can theoretically be assigned to the individual newsletter recipients, but we will only evaluate the data in anonymized form. The evaluations are made for getting to know our users' reading habits and to adapt our newsletter's content to them.

- c) **Legal basis:** The data you have provide when registering for the newsletter are processed at your consent (Art. 6 Para. 1 letter a of GDPR).

- f) **Rights of data subjects:** You have the right to information about the personal data from you that we have stored, to correction, deletion or limitation of processing, to object to processing, and the right to data portability (as stipulated by GDPR, see Art. 15–21 GDPR).

You can, at any time, revoke your consent to data processing effective for the future. Then you will no longer receive the newsletter. A link for cancelling the newsletter can be found at the end of each newsletter. The revocation does not affect processing done based on consent up to the time of revocation.

You can at any time, contact a supervisory authority with a complaint, e.g. the supervisory authority responsible for the federal state where you live, or the authority responsible for us.

- g) **Automated decision-making:** No automated decision-making (such as profiling) is done with your data.
- h) **Provision stipulated or required:** Your personal data are provided voluntarily, solely based on your consent. Unless you provide your personal data, we cannot send you the newsletter.
