

## Participation conditions and data protection information for the ROTHENBERGER bonus program

1. Any natural person 18 years old or over, living in the EU or Switzerland (see list of countries at the end of these conditions for participation) can participate in the ROTHENBERGER bonus program. All employees of the ROTHENBERGER Group are excluded from participation. All dealers and intermediaries and their employees are also excluded from participation.
2. The ROTHENBERGER bonus program has no time limit. However, please note the validity of the scratch card in your packet. ROTHENBERGER reserves the right to end the bonus program on four weeks' advance notice. If the bonus program is ended, the participants will receive notification of this and the opportunity to redeem the collected points before the deadline. The registered code can be redeemed within two years for a prize. After this time, validity expires.
3. There is no entitlement to participate in the bonus program. In particular, ROTHENBERGER reserves the right to delete or block the user account in event of misuse. The points collected up to that time are no longer honoured. If the code has already been redeemed, there is no right to conversion of bonus points. Cash payment of the bonus point balance is not possible. Each participant can redeem a maximum of 1,000 points. There is no right of legal appeal.
4. Data protection information.
  - a) **Responsible party and data protection officer:** The responsible body pursuant to data protection law, in particular the EU General Data Protection Regulation (GDPR), is ROTHENBERGER AG, Spessartstraße 2 - 4, 65779 Kelkheim, Germany.   - b) **Purpose of processing:** We process the personal data that you provide upon registering for the bonus program, and the personal data for operating the bonus program and for sending you the necessary information.
  - c) **Legal basis:** The data you have provided at registration are processed based on your consent (Art. 6 Para. 1 letter a of GDPR).
  - d) **Recipient:** The recipients of the data are the ROTHENBERGER AG subsidiaries organizationally integrated into the bonus program and the technical service providers who work for us as data processing contractors.
  - e) **Storage period:** We store your data as long as you remain registered, i.e. have not withdrawn from the bonus program. After that, it is deleted, unless legal storage requirements prevent this. You can demand deletion of your data at any time, and thus end your participation in the bonus program – see below.
  - f) **Rights of data subjects:** You have the right to information about the personal data from you that we have stored, to correction, deletion or limitation of processing, to object to processing, and the right to data portability (as stipulated by GDPR, see Art. 15–21 GDPR). You can, at any time, revoke your consent to data processing effective for the future. However, you can then no longer participate in the bonus program. The revocation does not affect processing done based on consent up to the time of revocation.

You can at any time, contact a supervisory authority with a complaint, e.g. the responsible supervisory authority of the federal state where you live, or the authority responsible for us.

- g) **Automated decision-making:** No automated decision-making (such as profiling) is done with your data.
- h) **Provision stipulated or required:** Your personal data are provided voluntarily, solely based on your consent. Unless you provide your personal data, we cannot grant you access to the bonus program.
